Like many of you, your president was saddened to learn of the untimely death of our member and friend, LaVonne Parker Ellis. We will miss her presence dearly.




# **April is Parliamentary Law Month**

On November 18, 2017, in celebration of Parliamentary Law Day, the Catherine Wittman Unit (Alexandria, Virginia) of the Virginia State Association of Parliamentarians hosted a workshop on parliamentary procedure. The title of the event was "Make Your

Meetings Great!" and focused on the fundamental principles outlined in *Robert's Rules of Order Newly Revised*, 11<sup>th</sup> ed. The event was conducted at the Beatley Central Library in Alexandria, Virginia, and was well attended by more than 60 participants from the general public.

Many attendees were elected officers, committee chairmen. appointed or parliamentarians of various community and civic groups, and government entities, who expressed a desire for a better understanding implementation and improved parliamentary procedure within their organizations. Other attendees were genuinely interested in learning foundation of a structured meeting, and how to make their meetings more efficient.

The Keynote Speaker was Ms. Darlene T. Allen (PRP), Vice President of the National Association of Parliamentarians. Ms.

Allen's topic, "Everything Must Change: The Motion to Amend," was very well received by both the attendees and the members of the Catherine Wittman Unit. The subject was thoroughly engaging and generated conversation on the ranking and handling of motions, amendments, debate, decorum, objections, and consent and approval.

The workshop also covered the following topic areas:

- Understanding Your Governing Documents
- Common Errors in Parliamentary Procedure
- When Your Question is Really an Answer: The Motion— Request for Information

The schedule of events included presentations by members of the Unit, a question and answer period, and concluded with a "fun facts" parliamentary quiz and door prizes.



The goal of the Law Day event was to instruct the audience on the fundamental principles of how an organization makes effective and efficient decisions while ensuring fairness to the minority while giving each member right to voice an opinion. The Catherine Wittman Unit believes that an educated assembly creates efficient rules for self-governance, and that

effective self-governance results in improved internal and external relationships and mutually beneficial practices. It hopes to offer similar workshops in the future.

Twenty-three of the twenty-five registered participants were present from a variety of community organizations. Representatives from many local churches, AARP, sororities, women groups, and groups focusing on children gathered to sharpen their parliamentary procedure skills.

Following a bountiful continental breakfast, time was allowed for a "getting to know you" phase. Participants were introduced to literature that is germane to successful meeting and given opportunities to win a copy of *Robert's Rules of Order Newly Revised*, 11<sup>th</sup> Edition, a copy of Robert's Rules of Order Newly Revised In Brief, and several authentic parliamentary note pads.





PLC President, Rev. Nancy Parker, gave an overview of the purpose of the workshop, the role of PLC to the community, and introduced the presenters for the day.

Both workshop presenters were motivating and informative in their interactive discussions that provided parliamentary procedure for effective meeting practices. **Topics** covered included: effective leadership in conducting meetings; proper handling of motions; and writing effective minutes. Participants were enthusiastic and had a thirst to learn more parliamentary procedure.
