<u>Ex-Officio Delegates</u>: Ex-Officio Delegates (Officers, Past Presidents, etc.) will be credentialed automatically upon registration.

#### **Proposed Bylaws Amendments**

The report of the Bylaws Committee is enclosed with this notice. In accordance with Article XIV, Section 2 of the VSAP Bylaws, notice of the following proposed bylaws amendments is hereby given:

- Amend Article XIV, Section 3 of the VSAP Bylaws by striking "unanimous" and inserting "three-fourths."
- Amend Article XIV, Section 3 of the VSAP Bylaws by adding "in the form of a written hard copy."
- Amend Article VI, Section 5A by 1) striking "by ballot" and 2) adding "If there is more than one nominee for a position, the election shall be by ballot."
- Amend Article VI, Section 1 by striking "The election shall be by ballot. A plurality shall elect and the member receiving the largest number of votes shall serve as chairman. In the event of a tie, the committee members shall meet prior to the adjournment of the Convention and elect the Chairman."

# Separate Registration for the Friday Afternoon Lecture at Monticello

# **Report of the Bylaws Committee**

Article XIV, Section 2 of the Virginia State Association of Parliamentarians Bylaws states, "These bylaws may be amended by the voting body of the Association by a two-thirds vote at a Convention, provided previous notice shall have been given in the Call to Convention." The following four amendments are submitted for consideration at the 2024 Annual Convention.

#### **Proposed Bylaws Amendment 1**

Submitted by the VSAP Bylaws Committee

Amend Article XIV, Section 3 of the VSAP Bylaws by striking "unanimous" and inserting "three-fourths."

**Submitter Rationale:** Under the current Bylaws language, a single member can prevent an amendment to the VSAP Bylaws. The Bylaws Committee would like to increase this threshold to 25% of the delegates, similar to how the NAP Bylaws allows for nine-tenths vote to approve last-minute amendments to the NAP Bylaws.

Recommendation: The Bylaws Committee recommends that the amendment be adopted.

### **Proposed Bylaws Amendment 2**

Submitted by the Virginia Peninsula Unit of Parliamentarians

**Submitter Rationale:** Last year at the VSAP Annual Association Convention there were several "last minute bylaw amendments" proposed. Because these amendments were presented to the voting body for the first time at the opening meeting and not in the convention meeting call, some voting members did not have time to write down, fully digest, and make proposed primary and/or secondary amendments to the proposed amendments. Whereas it may be natural in such a case to vote against the proposed amendment, there are times when adopting a last minute amendment is in the best interest of VSAP. In such a situation it is paramount that the voting body be given sufficient time to write down, fully digest, and propose primary and/or secondary amendments to the proposed bylaw amendment. The current bylaw amendment ensures that the VSAP Association Convention's voting body give due diligence to a proposed VSAP amendment.

**Recommendation:** The Bylaws Committee recommends that the proposed amendment be *postponed indefinitely*. The Convention already has the authority under RONR to create a rule that previous notice be reduced to writing: "If previous notice is given at a meeting, it can be given orally <u>unless the rules of the organization</u> require it to be in writing" (RONR, §10:47, emphasis added). The Bylaws Committee believes this matter is better addressed as a special rule of order or a standing rule instead of as an encumbrance in the Bylaws.

If the motion to postpone indefinitely is lost, the Bylaws Committee recommends that the convention approve a proviso that the amendment take effect upon the adjournment of the 2024 Annual Convention.

### **Proposed Bylaws Amendment 3**

Submitted by the VSAP Bylaws Committee

Amend Article VI, Section 5A by 1) striking "by ballot" and 2) adding "If there is more than one nominee for a position, the election shall be by ballot."

**Submitter Rationale:** This amendment would allow uncontested elections to be decided by acclamation, saving time. The convention would still retain the ability to order a ballot vote if it chooses.

**Recommendation:** The Bylaws Committee recommends that this amendment be adopted.

### **Proposed Bylaws Amendment 4**

Submitted by the VSAP Bylaws Committee

Amend Article VI, Section 1 by striking "The election shall be by ballot. A plurality shall elect and the member receiving the largest number of votes shall serve as chairman. In the event of a tie, the committee members shall meet prior to the adjournment of the Convention and elect the Chairman."

**Submitter Rationale:** This amendment would allow uncontested elections to be decided by acclamation, saving time. The convention would still retain the ability to order a ballot vote if it chooses. Additionally, this amendment would allow the chair of the committee to be decided under the procedure in RONR: "[T]he body that elects the committee members has the power, at the time the appointments are made, to designate any one of them as chairman. If a chairman is not designated when the committee is appointed, the committee has the right to elect its own chairman" (RONR, §13:18).

**Recommendation:** The Bylaws Committee recommends that this amendment be adopted.
